LIMITED CABLE PRODUCT WARRANTY

The following limited cable product warranty is exclusive and in lieu of all other warranties, whether express or implied, or statutory, including, but not by way of limitation, any warranty of merchantability or fitness for any particular purpose.

Pro Brand International, Inc. ("Pro Brand") warrants that all Cable Products (hereinafter referred to as "Products" or "Product"), are, at the time of shipment to the Buyer, free of material and workmanship defects, provided that no warranty is made with respect to:

- (1) Any Product which has been repaired or altered, by Buyer, its agents or employees, or any third party not under control of Pro Brand, in such a way, in Pro Brand's judgment, as to adversely affect the Product.
- (2) Any Product which has, in Pro Brand's judgment, been subject to negligence, accident or improper storage or transport by Buyer, its agents or employees, or any third party not under the control of Pro Brand.
- (3) Any Product which has not been installed, operated and maintained in accordance with normal practice in conformity with recommendations and published specifications of Pro Brand.

WAIVER OF DEFECTS BY RETENTION. Upon discovery of a defect, the Buyer shall notify Pro Brand in writing within 30 days following its discovery of the defect of any claim that Buyer may have with respect to any Products delivered hereunder. Failure to give such notice within the specified time shall constitute an unqualified acceptance and waiver of all claims and warranties with respect to the Products.

LIMITATION OF DAMAGES. Upon receipt of notice from Buyer of Non-Conforming Products, Pro Brand may inspect such Products at Buyer's location or installation or require that they be returned to Marietta, Georgia F.O.B. Pro Brand's corporate headquarters. At its option, Pro Brand shall repair, replace, or refund the purchase price of any non-conforming Product for a period of 12 months from the date of shipment of the Products to Buyer, and such obligations shall be the full extent of Pro Brand's liability. Any repairs or alterations which have not been authorized by Pro Brand shall void this warranty.

EXCEPT FOR THE LIMITED CABLE PRODUCT WARRANTY PROVIDED HEREIN, PRO BRAND MAKES NO WARRANTIES, EXPRESS OR IMPLIED, WITH RESPECT TO THE PRODUCTS INCLUDING (BUT NOT LIMITED TO) THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT WHATSOEVER SHALL PRO BRAND BE LIABLE (UNDER THIS OR ANY OTHER DOCUMENT) FOR ANY OTHER DAMAGES, INCLUDING LIABILITY OR CLAIMS FOR LOST PROFITS OR CONSEQUENTIAL DAMAGES ARISING OUT OF OR INABILITY TO USE THE PRODUCTS, EVEN IF PRO BRAND HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT WHATSOEVER SHALL PRO BRAND HAVE ANY LIABILITY TO BUYER OR THIRD PARTIES FOR ANY SPECIAL, INDIRECT, INCIDENTAL, OR EXEMPLARY DAMAGES, INCLUDING ANY LIABILITY FOR PENALTIES OR LIQUIDATED DAMAGES WHETHER SUCH CLAIM IS BASED UPON CONTRACT, TORT, OR ANY OTHER LEGAL THEORY. PRO BRAND SHALL NOT BE LIABLE FOR ANY DAMAGES INCURRED BY BUYER OR ANY THIRD PARTY FOR REMOVAL OF THE PRODUCT AFTER INSTALLATION OR THE INSTALLATION OF ANY REPLACEMENT PRODUCT WHETHER PROVIDED BY PRO BRAND OR ANOTHER THIRD-PARTY.

The Buyer consents that the exclusive venue of any legal action which in any way concerns the Products will be the Superior Court, Cobb County, Georgia. The parties further agree that all disputes relating to this limited product warranty or Pro Brand Products are governed by Georgia Law, and must be commenced within 12 months of the date of shipment of the Products to Buyer. Moreover, if Pro Brand brings a claim or counterclaim against Buyer, Buyer agrees that Pro Brand may recover from the Buyer all reasonable costs and attorney's fees.
